UFC PRIVACY POLICY

At Universal Family Connection, Inc. (UFC), your privacy is important to us.

INFORMATION WE COLLECT AND HOW WE USE IT

Cookies-When you visit the Universal Family Connection website, we may send one or more cookies - a small file containing a string of characters - to your computer or other device that uniquely identifies your browser. Cookies are used to improve the quality of our service, including storing user preferences, improving search results, and tracking user trends.

Log in Information- When you access Universal Family Connection's website, our servers automatically record information that your browser sends whenever you visit a website. These server logs may include information such as Internet Protocol (IP) address, browser type, and browser language, web requests including the date and time of your request, and one or more cookies that may uniquely identify your browser.

User Communications- When you send email or other communications to UFC, we may retain those communications in order to process your concerns, respond to your requests, and improve our services.

Link- Universal Family Connection may utilize links in a format that will enable us to keep track of whether those links are followed. This information is used to improve the quality of our searches and customized content.

Other sites- This Privacy Policy applies to Universal Family Connection's services only. We do not exercise control over any site displayed as a link from within our various services.

Universal Family Connection only processes personal information for the purposes described in this Privacy Policy for specific services. In addition to the above, such purposed include:

- o Providing services, including the display of customized content and advertising
- o Auditing, research and analysis in order to maintain protect and improve our services.
- o Ensuring the technical functioning of our website and network

These individuals are bound by confidentiality agreements and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.
